### Handling Procedures

1. Open vial according to enclosed instructions.
  - 2. Using a single tube of #44 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.**
  - 3. Aseptically transfer this aliquot back into the broth tube. Mix well.**
  - 4. Use several drops of the suspension to inoculate a #260 agar slant and/or plate.**
  5. atmosphere of 5% CO<sub>2</sub> for 2-3 days.

### Notes

Colonies on #260 agar after 2-3 days are pinpoint, whitish in color, smooth, opaque, and non-hemolytic.

It is important to use fresh medium that is less than two weeks old.
