### Handling Procedures

1. Open vial according to enclosed instructions.
2. From a single tube of #44 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the pellet.
3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.
4. Use several drops of this suspension to inoculate an additional broth tube, a #44

agar slant and/or a plate.

5. Incubate the tubes and plate at 37°C for 24 hours.

### Notes

Colonies are circular, with entire margin, convex elevation, and smooth surface. Cells are regular rods occurring singly, in pairs and short chains. Short rods are most common but longer rods also occur. Some cells exhibit tumbling motility. This strain is b-hemolytic on sheep blood agar.
