### Medium:

ATCC Medium 44: Brain Heart Infusion Agar/Broth

ATCC Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

**Temperature:** 37°C

**Atmosphere:** 5% Air, 5% CO<sub>2</sub>

## Handling Procedures

1. Open vial.
2. Rehydrate the entire pellet with approximately 0.5 mL of #44 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #44 broth. Additional test

tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary broth tubes.

3. Use several drops of the primary broth tube to inoculate a #260 plate and/or #260 agar slant.
  4. Incubate at 37°C for 1-2 days in an atmosphere of 5% CO<sub>2</sub>.

### **Notes**

Growth in an aerobic atmosphere will produce growth; however, growth is more robust in 5% CO<sub>2</sub>.
