Handling Procedures

1. Open vial according to enclosed instructions.
 2. Using a single tube of #44 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the pellet.
 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
 4. Use several drops of the suspension to inoculate a #260 agar slant and/or plate.

Notes

On #260 plates, colonies are entire, glistening, circular, smooth, convex, opaque, and exhibit beta hemolysis. This strain also grows on #44 plates.
