Handling Procedures

1. Open vial according to enclosed instructions.
2. From a single tube of #2706 broth (5 to 6 ml), withdraw approximately 0.6 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the pellet.
3. Use 0.5ml of this suspension to inoculate a #2706 slant and 0.1ml to inoculate #2706 plates.
4. Incubate tubes and plates at 28°C, under aerobic conditions, for 1-3 days.

Notes

Colonies on #2706 are: small, translucent, circular, entire, smooth, convex. Cells occur as clusters of nonmotile, thin bacilli.
