1. Open vial according to enclosed instructions.
  2. Using a single tube of #3 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
  3. Aseptically transfer this aliquot back into the broth tube. Mix well.
  4. Use several drops of the suspension to inoculate a second tube of broth, a slant, and/or plate.
  5. Incubate all tubes and plate at 26°C for 24-48 hours.

### **Notes**

Growth on agar yields convex colonies, less than 1.0 mm in diameter with entire margins and a translucent to opaque intrastucture.

Cells are irregular, short, motile rods, occurring predominantly in singles and pairs.
