Handling Procedures

1. Open vial according to enclosed instructions.
2. From a single tube of #13 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the pellet.
3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.
4. Use several drops of this suspension to inoculate an additional broth tube, a #13

agar slant and/or a plate. However, it may be advisable to allow initial growth to occur in broth before transferring to solid medium.

5. Incubate the tubes and plate at 26°C for 5 days.

Notes

Strain does not grow well on agar when first opened. Cells are slightly curved rods with rounded ends. Motility occurs in young stages and only weakly.
