ATCC highly recommends that appropriate personal protective equipment is always used when handling vials. For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

#### **Growth Conditions**

**Medium:** ATCC Medium 260: Trypticase soy agar/broth with defibrinated sheep blood **Temperature:** 37°C

#### Handling Procedures

1. Open vial according to enclosed instructions.

2. From a single tube of #44 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the entire pellet.

3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.

4. Use several drops of this suspension to inoculate a #260 agar slant and/or plate.

5. Incubate the tubes and plate at 37°C for 24-48 hours.

#### Notes

Growth is evident by good turbidity. On #260 plates, colonies are small, clear, circular, convex colonies with slight alpha-hemolysis under heavy growth.
