



# *Acinetobacter baumannii* Bouvet and Grimont

BAA-1605™

## Description

This whole-genome sequenced strain of *Acinetobacter baumannii* was isolated in 2006 from the sputum of a military personnel returning from Afghanistan entering a Canadian hospital. The bacterial culture is resistant to Ceftazidime, Gentamicin, Ticarcillin, Piperacillin, Aztreonam, Cefepime, Ciprofloxacin, Imipenem, and Meropenem. The strain is sensitive to Amikacin and Tobramycin.

## **Handling Procedures**

1. Open vial according to enclosed instructions.
2. Using a single tube of #18 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.

4. Use several drops of the suspension to inoculate a #18 agar slant and/or plate.
  5. Incubate the tubes and plate at 37°C for 24 to 48 hours.
