2. Rehydrate the entire pellet with approximately 0.5 mL of #0461 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #0461 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.
3. Use several drops of the primary broth tube to inoculate a #0461 plate and/or

#0461 agar slant.

4. Incubate at 70°C for 24 hours.
