Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Temperature: 37°C

Atmosphere: 95% Air, 5% CO₂

Handling Procedures

1. Open vial according to enclosed instructions.
 2. Using a single tube of #814 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
 4. Use several drops of the suspension to inoculate a #814 agar slant and/or plate.
 5. Incubate the tubes and plate at 37°C for 24-48 hours in an atmosphere of 5% CO₂. Loosen the screw caps during the incubation period.

Notes

Colonies on #814 agar are entire, glistening, circular, smooth, low convex.

Brain Heart Infusion (BD 237500) can be used to rehydrate vial contents if #814 broth is not available, but it will not support growth as well as the GC broth.
