## **Handling Procedures**

1. Open vial according to enclosed instructions.
  2. Using a single tube of #3 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
  3. Aseptically transfer this aliquot back into the broth tube. Mix well.
  4. Use several drops of the suspension to inoculate a #3 agar slant and/or plate.
  5. Incubate the tubes and plate at 37°C for hours.

### **Notes**

Colonies on #3 agar are translucent, cream, entire, smooth, and exhibit  $\beta$ -hemolysis.

This strain is positive for cholera toxin per the depositor.

CDC isolate number 2010EL-1786 from a person in the Artibonite Department, Haiti, from October 2010.
