Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## **Growth Conditions**

Medium: ATCC Medium 1099: CYE (Charcoal Yeast Extract) Buffered Medium Temperature: 35°C Atmosphere: 95% Air, 5% CO<sub>2</sub>

## Handling Procedures

1. Open vial according to enclosed instructions.

2. Using a single tube of #1099 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.

3. Aseptically transfer this aliquot back into the broth tube. Mix well.

4. Use several drops of the suspension to inoculate additional #1099 broth tubes, an agar slant, and/or plate.

5. Incubate the tubes and plate at 35°C for 72 hours.

#### Notes

Colonies on #1099 agar are gray, smooth, pinpoint, and punctiform.

*Legionella* species are nutritionally fastidious and are inhibited by media of poor caliber, so strict attention should be paid to the quality of the ingredients. The pH of the medium should be checked when cool, and is most critical. Unbuffered medium should not be used. Exposure of medium to light, particularly when hot, may also result in the accumulation of peroxides which can be inhibitory to the bacteria.
