*Escherichia coli* strain 2003-3014 is a whole-genome sequenced strain that was isolated from stool in Michigan. It is toxigenic and was confirmed by PCR to carry the *stx1*, *stx2*, and *eae* genes. This strain is serotype O26:H11 and it has applications for food testing, enteric disease research, and infectious disease research.

## Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #3 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0

- mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
  4. Use several drops of the suspension to inoculate a #3 agar slant and/or plate.
  5. Incubate the tubes and plate at 37°C for 24 hours.

## Notes

This strain was confirmed by PCR to carry the *eae*, *stx1*, and *stx2* genes (*stx1+*, *stx2+*, *eae+*).
