Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. Using a single tube of #18 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #260 agar slant and/or plate.

- 5. Incubate the tubes and plate at 37° C in an atmosphere of 5% CO₂ for 2-5days.
- 1. Open vial according to enclosed instructions.
- 2. Using a single tube of #18 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #260 agar slant and/or plate.
- 5. Incubate the tubes and plate at 37°C in an atmosphere of 5% CO₂ for 2 to 5days.
