## Description

*Staphylococcus aureus* strain M10/0148 is a methicillin-resistant bacterium that was isolated in 2010 from a 64-year-old female in-patient at an acute care hospital in Dublin. This strain is *pvl* negative and was confirmed by PCR to have the *mecC* gene. This product has applications for drug discovery and emerging infectious disease research.

Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## **Handling Procedures**

1. Open vial according to enclosed instructions.
2. Using a single tube of #3 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0

- mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
  4. Use several drops of the suspension to inoculate a #3 agar slant and/or plate.
  5. Incubate the tubes and plate at 37°C for 24 hours.

## Notes

Presence of *mecC* gene confirmed by PCR.

This strain contains a divergent *mecA* gene that is not detected by standard PCR kits (Shore AC, *et al.* Antimicrob. Agents Chemother 55(8): 3765-3773, 2011).
