This whole-genome sequenced strain of *Enterococcus faecium* was isolated from human feces. This strain is resistant to vancomycin and teicoplanin and was confirmed by PCR to carry the *vanA* gene. It has applications in antimicrobial resistance research and drug development research.

2. Rehydrate the entire pellet with approximately 0.5 mL of #44 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #44 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.
 3. Use several drops of the primary broth tube to inoculate a #44 plate and/or #44 agar slant.
 4. Incubate at 37°C for 24-48 hours.

The presence of the *vanA* gene has been confirmed by PCR.
