Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submerged in liquid nitrogen.

Handling Procedures

1. Open vial according to enclosed instructions. Pre-reduce media with 3% cysteine.
2. Using a single tube of #18 broth (5 to 6 mL) and under anaerobic conditions (see below), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.

3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a #260 agar slant and/or plate. An aerobic blood plate may also be streaked to check for purity.
5. Incubate the tubes and plate at 37°C for 1 week. No growth should occur on the aerobic blood plate.

ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

- Use of an anaerobic gas chamber;
- Placement of test tubes under a gassing cannula system connected to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loosen screw-caps on test tubes in anaerobic chamber;
- Loosen screw-caps on test tubes in an activated anaerobic gas pack jar,
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.
