1. Open vial according to enclosed instructions.
  2. Using a single tube of #1877 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
  3. Aseptically transfer this aliquot back into the broth tube. Mix well.
  4. Use several drops of the suspension to inoculate additional #1877 broth tubes, a #1877 agar slant, and/or plate.
  5. Incubate the tubes and plate at 22°C for 1 week.

Growth on #1877 is brown, translucent, and smooth.

This strain will grow on ISP #1 and nutrient agar, but will not grow on ISP #2 or tryptic soy agar.
