## Handling Procedures

1. Open thawed vial according to enclosed instructions or visit [www.atcc.org](http://www.atcc.org) for instructions.
2. Aseptically transfer the entire contents to a 5-6 mL tube of #2 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary broth tubes.

3. Use several drops of the primary broth tube to inoculate a #2 plate and/or #2 agar slant.
  4. Or, to obtain a biphasic culture, add several drops of the primary broth tube to a #2 agar slant. Best practice is to incubate these slants at an angle.
  5. Incubate at 30°C under microaerophilic conditions for 2 days. Use an anaerobe jar with an active catalyst and a microaerophilic gas generator pack or other acceptable method. All tubes and slants should be incubated with caps loosened.
