Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submerged in liquid nitrogen.

Handling Procedures

1. Open thawed vial according to enclosed instructions or visit www.atcc.org for instructions.
2. Under anaerobic conditions aseptically transfer the entire contents to a 5-6 mL tube of #5608 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary broth tubes. Best practice

dictates the use of pre-reduced media.

3. Use several drops of the primary broth tube to inoculate a #260 or Brucella blood plate and/or #260 agar slant.
4. Incubate in an anaerobic atmosphere at 37°C for 2-5 days. Incubate one agar plate aerobically at 37°C to check for contamination.

ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by the use of an anaerobic gas chamber or placement of test tubes under a gassing cannula system connected to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in an anaerobic chamber
- Loose screw caps on test tubes in an activated anaerobic gas pack jar
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained

Notes

Motile, non-spore forming, Gram positive rods. Nonhemolytic.

To establish growth, grow the strain in broth first then streak to agar.

Always use freshly prepared pre-reduced media or pre-reduced media that has been previously prepared but stored under anaerobic conditions.
