Description

Escherichia coli strain KL740 cI857+ is a bacterium that over-expresses a temperature-sensitive variant of the lambda phage repressor protein cI857. Below 30°C, cI857 forms a dimer and binds to the operator region of the P70a vector, preventing transcription of the gene downstream. At higher temperatures, cI857 becomes monomeric and falls off the operator, thus allowing gene transcription.

Handling Procedures

1. Open thawed vial.
2. Aseptically transfer the entire contents to a 5-6 mL tube of #1065 broth.

Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.

3. Use several drops of the primary broth tube to inoculate a #1065 plate and/or #1065 agar slant.
 4. Incubate at 30°C for 16-24 hours.
