Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

2. Rehydrate the entire pellet with approximately 0.5 mL of #3 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #3 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these

secondary tubes.

3. Use several drops of the primary broth tube to inoculate a #3 plate and/or #3 agar slant.
  4. Incubate at 37°C for 6-14 days.

## Notes

This organism is a facultative anaerobe.

This organism does not grow well on agar. An alternative media that can be used for growth is ATCC Medium #2215, however growth in ATCC Medium #3 broth is preferred.
