*Staphylococcus aureus* subsp. *aureus* strain HDE288 is a methicillin-resistant bacterium that was isolated from the pneumology ward of a hospital in Lisbon, Portugal. This strain has applications in antimicrobial resistance research, drug development, and infectious disease research.

1. Open vial according to enclosed instructions.

2. Using a single tube of #44 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
  3. Aseptically transfer this aliquot back into the broth tube. Mix well.
  4. Using several drops of the suspension, inoculate a second tube of broth, a #260 slant, and/or a plate.
  5. Incubate all tubes and plate at 37°C for 24 hours.
