## Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #1395 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a #173 agar slant and/or plate.

5. Incubate the tubes and plate at 37°C for one week.

## Notes

Colonies on #173 agar are rough, dry, heaped, orange and erose.
