Handling Procedures

1. Open vial according to enclosed instructions.
 2. Using a single tube of #18 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
 4. Use several drops of the suspension to inoculate a #18 agar slant and/or plate.
 5. Incubate the tubes and plate at 37°C for 24 hours.

Notes

This strain produces two colony types which are more readily seen on #260 agar: 1) Irregular, spreading, rough, white 2) Circular, glistening, smooth, low convex and white. Each of the colonies is a different serogroup. The irregular colony type is serogroup B and the circular colony type is serogroup D.
