ATCC Medium 2: Marine agar 2216 or marine broth 2216

**Temperature:** 22°C

**Atmosphere:** Aerobic

## Handling Procedures

1. Open vial according to enclosed instructions.
2. From a single tube of the recommended broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.
4. Use several drops of this suspension to inoculate an additional broth tube, an agar

slant and/or a plate.

5. Incubate the tubes and plate at 26°C for 72 to 96 hours.

## Notes

Colonies are smooth, entire, glistening, mucoid and yellow.
