## Description

SHM-D33 is a somatic B lymphoblast cell hybridoma that was isolated from the heteromyeloma of a mouse. This cell line was deposited by HS Kaplan and can be used in immunology research.

Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submerged in liquid nitrogen.

**Temperature:** 37°C

**Atmosphere:** 95% Air, 5% CO<sub>2</sub>

## Handling Procedures

### Unpacking and storage instructions:

1. Check all containers for leakage or breakage.
2. Remove the frozen cells from the dry ice packaging and immediately place the cells at a temperature below -130°C, preferably in liquid nitrogen vapor, until

ready for use.

**Complete medium:** HybriCare Medium (ATCC<sup>®</sup> No. 46X) supplemented with 20% high quality FBS (ATCC<sup>®</sup> 30-2020) and 0.2 mg/mL G418/Geneticin (Gibco 10131).

**Handling Procedure:** To insure the highest level of viability, thaw the vial and initiate the culture as soon as possible upon receipt. If upon arrival, continued storage of the frozen culture is necessary, it should be stored in liquid nitrogen vapor phase and not at -70°C. Storage at -70°C will result in loss of viability.

1. Thaw the vial by gentle agitation in a 37°C water bath. To reduce the possibility of contamination, keep the O-ring and cap out of the water. Thawing should be rapid (approximately 2 minutes).
2. Remove the vial from the water bath as soon as the contents are thawed, and decontaminate by dipping in or spraying with 70% ethanol. All of the operations from this point on should be carried out under strict aseptic conditions.
3. Transfer the vial contents to a centrifuge tube containing 9.0 mL complete culture medium. and spin at approximately 125 x g for 5 to 7 minutes.
4. Resuspend cell pellet with the recommended complete medium (see the specific batch information for the culture recommended dilution ratio). and dispense into a 25 cm<sup>2</sup> culture flask.
5. Incubate the culture at 37°C in a suitable incubator. A 5% CO<sub>2</sub> in air atmosphere is recommended if using the medium described on this product.

**Subculturing procedure:**

Cultures can be maintained by the addition of fresh medium. Alternatively, cultures can be established by centrifugation with subsequent resuspension at 2 to 4 x 10<sup>4</sup> viable cells/mL. Maintain cultures at a cell concentration between 3 x 10<sup>4</sup> and 8 x 10<sup>5</sup> cells/mL.

**Medium Renewal:** Every 2 to 3 days

**Note:** The cells are grown in 200 to 400 mcg/mL of G-418 to maintain selection for the human chromosomes.

**Reagents for cryopreservation:** Complete growth medium supplemented with 7.5% (v/v) DMSO (ATCC 4-X)
