Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submerged in liquid nitrogen.

### **Handling Procedures**

**Frozen ampoules** packed in dry ice should either be thawed immediately or stored in

liquid nitrogen. If liquid nitrogen storage facilities are not available, frozen ampoules may be stored at or below  $-70^{\circ}\text{C}$  for approximately one week. **Do not under any circumstance store frozen ampoules at refrigerator freezer temperatures (generally  $-20^{\circ}\text{C}$ ).** Storage of frozen material at this temperature will result in the death of the culture.

1. To thaw a frozen ampoule, place in a  **$25\text{-}30^{\circ}\text{C}$**  water bath, until just thawed ( **approximately 5 minutes**). Immerse the ampoule just sufficient to cover the frozen material. Do not agitate the ampoule.
2. Immediately after thawing, wipe down ampoule with 70% ethanol and aseptically transfer at least 50  $\mu\text{l}$  (or 2-3 agar cubes) of the content onto a plate or broth with medium recommended.
3. Incubate the inoculum/strain at the temperature and conditions recommended.
4. Inspect for growth of the inoculum/strain regularly. The sign of viability is noticeable typically after 1-2 days of incubation. However, the time necessary for significant growth will vary from strain to strain.

**Morphology:** After 5 days on YEPD medium at  $30^{\circ}\text{C}$  , colony is off-white, butyrous, smooth and glossy. Cells are small, ovoid, single, in pairs or clusters; pseudohyphae were not observed.
