important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Growth Conditions

Medium:

ATCC Medium 1525: Seawater 802 medium

ATCC Medium 1405: HESNW medium

Instructions for complete medium:

Media: ATCC Medium 1525 inoculated with *Klebsiella pneumoniae* subsp. *pneumoniae* (ATCC® 700831™) or *Enterobacter aerogenes* (ATCC® 13048™).

Alternate Media: ATCC® Medium 1525 and ATCC® Medium 1405 HESNW medium, combined in equal parts and inoculated with *Klebsiella pneumoniae* subsp. *pneumoniae* (ATCC® 700831™) or *Enterobacter aerogenes* (ATCC® 13048™).

Note about growth media: Culture growth and longevity may be improved slightly by using previously-bacterized ATCC Medium 1525 diluted 1:1 with ATCC Medium 1405, which reduces bacterial density in the culture medium.

Handling Procedures

Storage and Culture Initiation

Frozen ampules packed in dry ice should either be thawed immediately or stored in liquid nitrogen. If liquid nitrogen storage facilities are not available, frozen ampoules may be stored at or below -70°C for approximately one week. **Do not under any circumstance store frozen ampules at refrigerator freezer temperatures (generally -20°C).** Storage of frozen material at this temperature will result in the death of the culture.

1. To thaw a frozen ampule, place it in a 35°C water bath such that the lip of the ampule remains above the water line. Thawing time is approximately 2 to 3 minutes. Do not agitate the ampule. Do not leave ampule in water bath after it is thawed. Do not allow ampule to overheat.
2. Add the thawed contents to a T-25 flask containing 10 ml of ATCC medium 1525 bacterized with *Klebsiella pneumoniae* subsp. *pneumoniae* (ATCC® 700831™) or *Enterobacter aerogenes* (ATCC® 13048™).
3. Incubate the culture at 25°C with the cap screwed on tightly.

Culture maintenance: Subculture every 2-3 weeks to a fresh T-25 flask of bacterized medium in the following manner:

1. Aseptically transfer 0.5 ml from a growing culture to a T-25 tissue culture flask containing 10.0 ml of ATCC medium 1525 bacterized with *Klebsiella pneumoniae* subsp. *pneumoniae* (ATCC® 700831) or *Enterobacter aerogenes* (ATCC® 13048).
2. Incubate flask at 25°C with the cap on tightly.

Reagents for cryopreservation:

Cryoprotective Solution

DMSO, 2.0 ml

Fresh growth medium w/o bacteria, 8.0 ml

Cryopreservation:

1. Mix the components in the order listed. When the medium is added to the

- DMSO the solution will warm up due to chemical heat.
2. Harvest cells from a culture that has recently passed peak density by centrifugation at 1200-1600 x g for 10 min.
 3. Adjust the concentration of cysts at least 2×10^5 /ml in fresh medium.
 4. Mix the cell preparation and the cryoprotective solution in equal portions.
 5. Dispense in 0.5 ml aliquots into 1.0 - 2.0 ml sterile plastic screw-capped cryules (special plastic vials for cryopreservation).
 6. Place vials in a controlled rate freezing unit. From room temperature cool at $-1^\circ\text{C}/\text{min}$ to -40°C . If freezing unit can compensate for the heat of fusion, maintain rate at $-1^\circ\text{C}/\text{min}$ through heat of fusion. At -40°C plunge ampules into liquid nitrogen. Alternatively, place the vials in a Nalgene 1°C freezing apparatus. Place the apparatus at -80°C for 1.5 to 2 hours and then plunge ampules into liquid nitrogen. (The cooling rate in this apparatus is approximately $-1^\circ\text{C}/\text{min}$.)
 7. Ampules are stored in either the vapor or liquid phase of a nitrogen refrigerator.
 8. To establish a culture from the frozen state place the vial in a 35°C water bath. Immerse the vial to a level just above the surface of the frozen material. Do not agitate the vial. Immediately after thawing, do not leave in water bath, aseptically remove the contents of the ampule and inoculate into a T-25 tissue culture flask containing 10 ml of ATCC medium 1525 bacterized with *Klebsiella pneumoniae* subsp. *pneumoniae* (ATCC® 700831™) or *Enterobacter aerogenes* (ATCC® 13048™).
 9. Incubate the culture at 25°C with the cap screwed on tightly.

Once the culture is established, follow the protocol for maintenance of culture.
