pENTR\_L4R1\_pGPD- BM3R1 contains an ATCC synthetic promoter flanked by two Gateway® recombination *att* sites (*attL4* and *attR1*). The promoter consists of a TetR homolog BM3R1 operator and a strong yeast GPD promoter. It can be repressed by BM3R1 (TetR homolog) via binding of BM3R1 to its cognate operator sequence (ATTGATTGGACGTTCAATATAA) within the promoter. It is one of promoters in the ATCC® Synthetic Biology Yeast Tool Kit (Detailed information is described in the ATCC® [Synthetic Biology Solutions User Guide](#)). Before opening the vial, centrifuge at 6,000 x g for 30 seconds. Add 30 µL of Molecular Grade Water and incubate the vial at 4°C overnight to dissolve the DNA. Each vial contains 2-3 µg plasmid DNA (measured by PicoGreen® dsDNA quantitation assay).
