material also grows adequately on BHI agar or BHI broth. Aseptically transfer the contents to a 5-6 mL tube of #1685 broth. Incubate in 5% CO₂ atmospheric conditions at 37°C for 24-48 hours w/ shaking. Remains stable at room temp for 4-5 days. Does not tolerate refrigeration at 10°C.
