Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

IHD-W is the strain used by Dales to develop a large group of its mutants in the 70s. IHD-W differs from the IHD-J parent strain, in that IDH-W is unable to induce an active hemagglutinin in the plasma membrane and does elicit polykaryoctosis.
