Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

### Growth Conditions

**Host:** Vero (ATCC CCL-81)

**Effects:** cell rounding; cell sloughing; CPE; plaque formation

**Complete medium:**

EMEM (ATCC® 30-2003™) + 10% FBS (ATCC® 30-2020™)

**Temperature:** 37°C

**Atmosphere:** 95% Air, 5% CO<sub>2</sub>

**Recommendations for infection:** Plate cells 24 hours prior to infection and infect when cultures are 80-90% confluent. Remove medium and inoculate with a small volume of virus (e.g. 1 mL per 25 cm<sup>2</sup>) diluted to provide an optimal MOI. Adsorb 1 hour at 37°C in a humidified 5% CO<sub>2</sub> atmosphere. End adsorption by adding virus growth medium.

**Incubation:** 3-7 days at 37°C in a humidified 5% CO<sub>2</sub> atmosphere, until CPE is progressed throughout monolayer

17D is a vaccine strain attenuated by serial passaging of the Asibi strain in chicken embryo tissue culture.
