Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Notes

VR-1566 was derived from the same CEF-passaged seed stock as was VR-1508, but VR-1566 was maintained in CEF cells (ATCC® # CRL-1590). The passage history of the MVA strain is complex (see Mayr & Stickl (1975)). The MVA Ankara strain has been passaged hundreds of times in CEF cells and does not replicate in human cells or the majority of mammalian cells. This is a highly attenuated strain of vaccinia that some experts feel can be handled safely by trained personnel without the need for vaccination. This strain has been sequenced (Genbank U94848).
