important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

### Growth Conditions

**Host:** A-72 (ATCC CRL-1542)

**Effects:** cell rounding; cell sloughing; CPE

**Complete medium:**

DMEM (ATCC<sup>®</sup> 30-2002<sup>™</sup>) + 2% FBS (ATCC<sup>®</sup> 30-2020<sup>™</sup>)

**Temperature:** 34°C

**Atmosphere:** 95% Air, 5% CO<sub>2</sub>

**Recommendations for infection:** Plate cells 24-48 hours prior to infection and infect when cultures are 80-90% confluent. Remove medium and inoculate with a small volume of virus (e.g. 1 mL per 25 cm<sup>2</sup>) diluted to provide an optimal MOI (e.g. 0.1). Adsorb 1-2 hours at 34°C in a humidified 5% CO<sub>2</sub> atmosphere, rocking every 20-30 minutes to redistribute inoculum. End adsorption by adding virus growth medium.

**Incubation:** 2-4 days
