Description

Human herpesvirus 2 strain ATCC-2011-2 is propagated in Vero cells (ATCC CCL-81). The virus was isolated from a clinical sample from a patient positive for HSV-2 in Virginia in 2011. It has applications in infectious disease and sexually transmitted disease research.

ATCC highly recommends that appropriate personal protective equipment is always used when handling vials. For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Growth Conditions

Host: Vero (ATCC CCL-81)

Effects: CPE; cell rounding

Temperature: 37°C

Atmosphere: 95% Air, 5% CO₂

Recommendations for infection: Plate cells 24-48 hours in advance and infect when cultures are 80-90% confluent. Remove medium, rinse monolayer with plain Virus growth medium: EMEM. Inoculate with a small volume (e.g. 1 mL per 25 cm²) of virus diluted to provide a MOI of about 0.1. Adsorb 1-2 hours at 37°C in a humidified 5% CO₂ atmosphere, rocking every 15-20 minutes to redistribute inoculum. End adsorption by adding virus growth medium.

Incubation: 2-4 days in a humidified 5% CO₂ atmosphere
