Influenza B virus (Yamagata Lineage) strain B/Wisconsin/1/2010 is propagated in SPF embryonated chicken eggs. The virus was isolated in 2010 from a human patient in Wisconsin. It has applications in infectious disease and respiratory disease research and vaccine development.

Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Incubation: 2-3 days at 35°C in a humidified, non-CO₂ atmosphere.
