## Description

Influenza B virus (Victoria Lineage) strain B/Florida/78/2015 is propagated in MDCK (NBL-2) cells (ATCC CCL-34). This strain was isolated in 2015 from a human in Florida. It has applications in infectious and respiratory disease research.

## Growth Conditions

**Host:** MDCK (NBL-2) (ATCC CCL-34)

**Effects:** cell rounding; cell sloughing; CPE

**Complete medium:**

DMEM (ATCC 30-2002) + 0.18% BSA (Invitrogen™ 15260), 24 mM HEPES (Invitrogen™ 15630), + 2 µg/mL TPCK-treated Trypsin (Sigma-Aldrich® T1426)

**Temperature:** 35°C

**Atmosphere:** 95% Air, 5% CO<sub>2</sub>

**Recommendations for infection:** Plate cells 18-24 hours prior to infection and infect when cultures are 80-90% confluent. Remove medium and inoculate with a small volume of virus (e.g. 1 mL per 25 cm<sup>2</sup>) diluted to provide an optimal MOI (e.g. 0.1 to 0.01). Adsorb 1-2 hours at 35°C in a humidified 5% CO<sub>2</sub> atmosphere. End adsorption by adding virus growth medium.

**Incubation:** 2-3 days at 35°C in a humidified 5% CO<sub>2</sub> atmosphere, until CPE is

progressed through 75% of the monolayer.
