### Growth Conditions

**Host:** Vero E6-hSLAM cells

**Effects:** syncytia; cell fusion

**Complete medium:** DMEM (ATCC 30-2002) + 2% FBS (ATCC 30-2020)

**Temperature:** 37°C

**Recommendations for infection:** Plate cells 1-2 days prior to infection and infect when cultures are 90% confluent. Remove medium and inoculate with a small volume of virus (*e.g.*, 1 mL per 25 cm<sup>2</sup>) diluted to provide an optimal MOI (*e.g.*, 0.01). Adsorb 1-2 hours at 37°C in a humidified 5% CO<sub>2</sub> atmosphere. End adsorption by adding virus growth medium.

**Incubation:** 2-4 days at 37°C in a humidified 5% CO<sub>2</sub> atmosphere, until CPE is progressed through 80% of the monolayer.
