## Description

Human herpesvirus 1 strain HF is propagated in Vero cells (ATCC CCL-81). This strain was isolated in 1922 from the vesicle fluid of a human patient with recurrent herpes simplex in New York, US. It has applications in testing disinfectants and infectious disease and sexually transmitted disease research. Vials of this product contain total fluid and material from cell culture infected by virus; cellular debris and possibly cells containing cell-associated virus will be present.

ATCC highly recommends that appropriate personal protective equipment is always used when handling vials. For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## Growth Conditions

**Host:** Vero (ATCC CCL-81)

**Effects:** cell rounding; cell sloughing; CPE; syncytia

**Complete medium:**

EMEM (ATCC 30-2003) + 2% FBS (ATCC 30-2020)

**Temperature:** 37°C

**Atmosphere:** 95% Air, 5% CO<sub>2</sub>

**Recommendations for infection:** Plate cells 24 to 48 hours prior to infection and infect when cultures are 80-90% confluent. Remove medium and inoculate with a small volume of virus (e.g., 1 mL per 25 cm<sup>2</sup>) diluted to provide an optimal MOI (e.g.,

0.1). Adsorb 1-2 hours at 37°C in a humidified 5% CO<sub>2</sub> atmosphere, rocking every 20 to 30 minutes to redistribute inoculum. End adsorption by adding virus growth medium.

**Incubation:** 2-3 days
