Mayaro and SemLiki Forest viruses are closely related but can be distinguished by HA and CF tests; an immune serum for either will neutralize the other in neutralization tests in mice (Casals, J. et al., Am. J. Trop. Med. Hyg. 6: 1004, 1957). Not pathogenic for adult mice.
