Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Growth Conditions

Host: JH4 clone 1 (ATCC CCL-158)

Effects: cell rounding; cell sloughing; CPE

Complete medium:

F-12K (ATCC[®] 30-2004[™]) + 2% FBS (ATCC[®] 30-2020[™])

Temperature: 37°C

Atmosphere: 95% Air, 5% CO₂

Recommendations for infection: For best results, infection should be performed on a 80-90% confluent, 18-48 hour old cellular monolayer. Prepare dilution of virus in minimum amount of volume (e.g. 1 mL per 25 cm²). Wash monolayer with PBS or serum free medium prior to inoculation. Adsorb virus dilution for 1-2 hours at 37°C in a humidified 5% CO₂ atmosphere, rocking every 20-30 minutes to redistribute inoculum. End adsorption by adding virus growth medium.

Incubation: 9-21 days at 37°C in a humidified 5% CO₂ atmosphere, until CPE is progressed through 80% or greater of the monolayer.

Bring total suspension to 10% FBS prior to freezing harvested virus.
