ATCC® Medium 1100: Sucrose-peptone agar

### Growth Conditions

**Temperature:** 26°C

**Atmosphere:** Aerobic

### Propagation Procedure

1. Open vial according to enclosed instructions.
2. Using a single tube of #1100 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a #1100 agar slant and/or plate.
5. Incubate the tubes and plate at 26°C for 48-72 hours.

## Notes

Colonies on #1100 agar are entire, smooth, convex, white, glistening, opaque, and surrounded by a clear halo of mucous.
