ATCC® Medium 18: Trypticase Soy Agar/Broth

### Growth Conditions

**Temperature:** 30°C

**Atmosphere:** Aerobic

### Propagation Procedure

Frozen mini-cryovials packed in dry ice should either be thawed immediately for use or stored at or below -70°C until the expiration date printed on the label. Storage at -20°C may affect the growth and viability of the culture.

1. Thaw the bacterial strain upright using gentle agitation in a 25°C to 30°C water bath. Thawing will be rapid; approximately 2-3 minutes or until all ice crystals have melted.
2. Immediately after thawing, wipe down the mini-cryovial with 70% ethanol and aseptically transfer the entire contents to a 5-6 mL tube of #18 broth or directly inoculate a #18 plate and/or #18 agar slant.
3. Discard the empty vial. Do not refreeze any unused portion as it will result in a loss of viability.
4. Incubate at 30°C for 24 to 48 hours.
