**Product Description:** ATCC® 49619-MINI-PACK™ consists of 6 ready-to-use vials of ATCC® 49619™ frozen in 200 µL of glycerol stock, eliminating the need to rehydrate and culture the strain prior to use. Each vial is provided with a 2-D barcode for easy storage and tracking, as well as peel-off labels for fast and reliable recordkeeping.

## Propagation

### Medium

ATCC® Medium 44: Brain Heart Infusion Agar/Broth

ATCC® Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

### Growth Conditions

**Temperature:** 37°C

**Atmosphere:** 5% CO<sub>2</sub>

### Propagation Procedure

Frozen mini-cryovials packed in dry ice should either be thawed immediately for use or stored at or below -70°C until the expiration date printed on the label. Storage at -20°C is acceptable for up to 1 year.

1. Thaw the bacterial strain upright using gentle agitation in a 25°C to 30°C water bath. Thawing will be rapid; approximately 2-3 minutes or until all ice crystals have melted.
2. Immediately after thawing, wipe down the ampoule with 70% ethanol and aseptically transfer the entire contents to a 5-6 mL tube of #44 broth or directly inoculate a #260 plate and/or #260 agar slant.
3. Discard the empty vial. Do not refreeze any unused portion as it will result in a loss of viability.
4. Incubate at 37°C for 24 hours in an atmosphere of 5% CO<sub>2</sub>. Screw caps should be loose.

## Notes

This strain will lyse if incubated for 48 hours or longer.

An additional transfer may be required after initial 24 hours of growth in order to fully remove cyroprotectant and achieve acceptable growth.
