Propagation Procedure

1. Open vial according to enclosed instructions.
2. Using a single tube of #3 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate an additional broth tube, a #3 agar slant and/or a plate.
5. Incubate all tubes and plate at 30°C for 24 hours.

Notes

This item grows well in broth, but may not grow on agar upon rehydration from the freeze-dried pellet. Subsequent transfers will grow well on agar. Additional information on this culture is available on the ATCC® web site at www.atcc.org.
