## Propagation

### Medium

ATCC® Medium 18: Trypticase Soy Agar/Broth

### Growth Conditions

**Temperature:** 37°C

**Atmosphere:** Aerobic

### Propagation Procedure

1. Open vial according to enclosed instructions.
2. From a single tube of #18 broth (5 to 6 mL), withdraw approximately 0.5 to 1 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a #18 agar slant and/or plate.
5. Incubate all tubes and plate at 37°C for 24 hours.

## Notes

Colonies on #18 plates are entire, glistening, circular, smooth, and white after 24 hours incubation. Two colony types (white and yellow-orange) may be seen as culture ages and is typical for this strain. It produces coagulase and beta-hemolysis on sheep blood agar.
