## Description

**Genotype:** Presence of *vanB* gene confirmed by PCR

**Product Description:** Resistant to vancomycin. Sensitive to teicoplanin.

## Propagation

### Medium

ATCC® Medium 44: Brain Heart Infusion Agar/Broth

ATCC® Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

### Growth Conditions

**Temperature:** 37°C

**Atmosphere:** Aerobic

### Propagation Procedure

1. Open vial according to enclosed instructions.
2. Using a single tube of #44 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a #260 agar slant and/or plate.
5. Incubate the tubes and plate at 37°C for 24 hours.

## Notes

Colonies on #260 agar are entire, glistening, circular, smooth, low convex, and dull white.

PCR confirms presence of *vanB* gene conferring vancomycin resistance.
