### Propagation Procedure

1. Open thawed vial according to enclosed instructions or visit [www.atcc.org](http://www.atcc.org) for instructions.
2. Thaw vial at room temperature. Aseptically transfer the entire contents to a 5-6 mL tube of #18 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.
3. Use several drops of the primary broth tube to inoculate a #18 plate and/or #18 agar slant.
4. Incubate at 37°C for 24 hours.

## Notes

Colonies on #18 agar may appear entire, glistening, smooth, and low convex.
